1	Go To http://www.esc11.net/
2	Click on Register
3	Click on Sign In - <i>Create an account if you do not have one. If this is your first time registering for a session with Region 11, click on Sign Up located in the upper right corner; otherwise, select Sign In.</i>
4	Hover Over Browse Catalog
5	Select Subject & Click
6	Click on Statutory Training
7	Click on a required courses below and register

8	Change the session date if desired <i>(you will have 1 week to complete all 11 courses once you register)</i>
<p><u>Session Dates (aka Training Cycle)</u></p> <p><i>Each of the eleven self-paced courses listed above will be available during each training cycle shown here. Participants may complete all courses within a single training cycle or elect to complete different courses in different cycles. At the conclusion of a training cycle, if the participant has completed all of the required course activities, their name will be submitted to Region 11's Registration Office.</i></p>	

The participant will then receive a confirmation email that includes a link to a course evaluation. **The session, along with its credit hours, will appear in their transcript once they complete the course evaluation.**

August 15th-August 21st

**Please do not register any later than the 8/15-8/21 window. Employees should have Compliance Trainings completed prior to the first day of school.*

You will receive an e-mail confirming your registration

10 Take the courses during your session dates & complete the survey

11 Print certificates and give them to your campus secretary no later August 19th, 2016.
